I GENERAL TERMS

The General Provisions of the General Technical Approval No. Z-42.1-432 shall be replaced by the following version:

- 1 The general technical approval proves the usability of the object of approval within the meaning of the state building regulations.
- 2 The general technical approval does not replace the permits, approvals and certificates required by law for the implementation of construction projects.
- 3 The general technical approval is granted without prejudice to the rights of third parties, in particular private property rights.
- 4 Without prejudice to further provisions in the "Special Provisions", manufacturers and distributors of the subject matter of the registration must provide the user of the object of registration with copies of the general technical approval and point out that the general technical approval must be available at the place of use. Copies of the general technical approval must also be made available to the authorities involved on request.
- 5 The general technical approval may only be reproduced in its entirety. Publication in excerpts requires the approval of the German Institute for Construction Technology [DIBt]. Texts and drawings of advertising leaflets may not contradict the general technical approval. Translations of the general technical approval must contain the note "Translation of the original German version not checked by the German Institute for Building Technology".
- 6 The general technical approval is granted revocably. The provisions of the general technical approval can be supplemented and amended subsequently, in particular if new technical findings require this.
- 7 This decision refers to the information provided by the applicant in the authorisation procedure on the subject matter of the authorisation and the documents submitted. A change in these approval bases is not covered by this decision and must be disclosed immediately to the German Institute for Construction Technology.
